### **HMERP Exercise Subcommittee:**

Vice Chairman Ranck reported that they will be reaching out to critical hazard facilities to do a tabletop exercise.

### **CCC Liaison Updates:**

Chairman Peterson and Vice Chairman Ranck attended the Citizen Corps Council's March 23, 2017, meeting. Planning is ongoing for "Ready, Set, No" for this September. Update to Fairfax County website for the CCC, funding discussed. Matt Marque is a new member on the CCC. The next meeting is scheduled for May 25, 2017.

#### **Liaison with other LEPCs:**

Vice Chairman Ranck attended LEPC meeting in Prince William County where monitoring of illegal dumping, illegal car washing activities, and paint being released into stormdrains. Trice Burgess reported that a regional committee is being developed to incorporate inactive LEPC committees to include the City of Fredericksburg, Rappahannock County, and King George County. The State of Virginia has already approved formation of this committee; however, each jurisdiction is still required to a have local LEPC. There was further discussion on illegal dumping, mobile gas filling vehicles, and other hazmat related issues.

#### Shelter in Place Video:

Chairman Peterson toured the Fairfax County Public Safety Communication Center on March 30, 2017. He also discussed the video and possible lead in ideas. Bob DeMarco is still on track for the video to be released in June 2017.

# **HAZMAT RESPONSE TEAM (HMRT) UPDATE**

### **RECENT INCIDENTS**

Vice Chairman Ranck reported on the following incidents:

- EOD/bomb squad investigated a suspicious package
- Several reports of gas leaks
- Minor flammable liquid spill and fumes where citizen was mixing chemicals in his basement and EMS responded

## **HMRT TRAINING**

Vice Chairman Ranck reported:

- A team drill was held in March at Lorton training facility with a mock high tanker incident
- A hazmat "show and tell" was held at Fairfax Hospital for staff to see how Fairfax County responds
- A radiation drill for the Fairfax County Hazmat Team is being held in April 2017.

### FJLEPC COORDINATOR UPDATE

#### Tier II Manager Update & HMERP

Trice Burgess reported he continues to send out invoices for Tier II reporting. There are 140 critical hazard facilities in Fairfax County, 98 percent being sulfuric acid for batteries. Trice will coordinate with the webmaster to update the website with our meeting minutes. Hazardous Materials Emergency Response Plan will be coming out in June 2017.

### **EQAC**

Johna Gagnon reported that on April 12, 2017, that the decision was made to report to the Board of Supervisors and remove the hazmat chapter from the EQAC report. There was discussion regarding who is reviewing the report and the time it takes to review. Some parts of the hazmat chapter will be kept, and an historical data base may be created.
