Public Communications: Greg Zebrowski no update.

**Business Outreach:** Greg Zebrowski reported the Office of Emergency Management continues working with the Business Emergency Operations Council.

#### **HMERP Exercise Subcommittee:**

Battalion Chief David Sellers reported the exercise was held on October 21, 2020. It was a flammable liquid spill event that occurred in 2015. The actions deployed and resources used were reviewed. Very positive exercise. Attendees were able to see new foam equipment displayed outside. Trice Burgess shared pictures from the exercise. Next year's exercise is tentatively scheduled for October 5, 2021.

#### **CCC Liaison:**

Ashley Morris, OEM, reported the following:

- CCC is working closely with the district supervisor offices through supervisor representatives and district driven preparedness projects. The council aims to work to identify specific preparedness projects in each district and complete them through coordination of OEM CE, citizen corps programs, and affiliated organizations of the council. We also hope to increase the visibility of the citizen corps in the public eye through better public information.
- They will be increasing council member coordination and info sharing through a new website, digital calendar, and bulletin board.
- One goal of the council is to support public safety outreach as well (PD, FD, Dispatch) through public safety days, Stop the Bleed, CPR, and other every-day emergency training and events. Not only is there a need for basic emergency skills and preparedness, but we can also use these skills and information to segway into disaster skills and preparedness, which typically seem less likely to occur to the person.

Chairman Ranck reported that most of the local LEPC's have not been holding meetings due to the COVID-19 pandemic. Bowman Olds reported that Prince William County LEPC continues working on enhancement of public and private partnerships.
