RECENT INCIDENTS

David Sellers reported there was an 8" gas main (Washington Gas) leak in the Mantua area of Fairfax County, detected by Fairfax Water working in the area. The cause of the leak appears to be aging rust.

There was a significant security event in the Reston area which involved mail containing suspicious items, including an unknown "powder" substance. Matter was turned over to the FBI for investigation. He will follow-up if further information becomes available.
