HMERP Exercise Subcommittee:

Vice Chairman Ranck reported that the next HMERP exercise will be in September 2019 with date to be confirmed in the near future.

Chairman Ranck will facilitate that request. Also, there was discussion on changing their meeting schedule from evening to daytime meetings to encourage more participation.

Prince William County – Chairman Ranck and Vice Chairman Jolley attended the March meeting. The PWC Health Dept. gave a presentation on an epidemiology response to a mass event.

Chairman Ranck stated all work is complete on the Shelter-in-Place video and asked that it be removed from the meeting agenda at this time.

HAZMAT RESPONSE TEAM (HMRT) UPDATE

RECENT INCIDENTS

Chairman Ranck reported on recent significant incidents.

Tanker carrying over 8,500 gallons of gasoline overturned on the American Legion Bridge on I-495, requiring many hours of cleanup. A saddle tank traveling on I-495 near Van Dorn exit, along shoulder of road leaking diesel, ignited some foam boards. Inova Fairfax Hospital property (old Exxon Mobile site) requested DEQ onsite for a spill of approximately 3,000 gallons of diesel fuel from underground tanks;

HMRT TRAINING

Chairman Ranck reported on a foam drill held at the Newington tank farm, with all three shifts participating over a period of three days. A "dirty" bomb event simulation was held in March for all three shifts.

FJLEPC COORDINATOR UPDATE

Tier II Manager Update & HMERP

Chairman Ranck gave the following report due to the absence of Tier II Manager, Trice Burgess.

Total No. of Inactive Facilities – 157

98+% (431) of our active facilities have reported for 2018;

An email was sent out requesting FJLEPC members and participants to provide information if they are a FJLEPC member, if they are voting member (or who is for their organization) and if they wished to remain on the FJLEPC emailing list. Trice has compiled a category of voting FJLEPC members in Outlook. He will provide VA DEQ /VERC this info when they request it in the next few months. He has completed entering all of the 2018 Tier II active reporting facilities (437) into our CAD Location of Interest (LIO) files. All these facilities should show up during dispatch to give our first responders a heads up that chemical hazards may be present at these facilities. Billing information has been provide to the FMO Revenue and Records section to process invoices for all facilities located in Fairfax County that the Fire Department is allowed to bill.

He will start working on the 2019 FJLEPC Hazardous Materials Emergency Response Plan in the coming months, and hopes to have it reviewed and finished by our August meeting. If anyone has information they would like to add to the FJLEPC website, please let Trice know. He will be replacing older informational and news type links with more current information.
