FJLEPC MEETING CALLED TO ORDER

Chairman Richard Michelback, called the April 11, 2024, meeting of the Fairfax Joint Local Emergency Planning Committee to order at 10:00 a.m. He welcomed everyone to the virtual meeting, and roll call was taken by Trice Burgess. (See above)

APPROVAL OF MINUTES

Chairman Michelback asked everyone if there were any suggestions, edits, or requests to the February 8, 2024, meeting minutes. It was decided that we're going to stop doing the transcripts and switch over to our regular meeting minutes. By doing this, it will make them a little bit shorter, more concise, maybe a little easier for all of us to go over, and it will directly address the issues that we discussed without a lot of extraneous detail.

Chairman Michelback noted: If no one has any objections and/or suggestions for the February 8th minutes, to get someone to motion that we adopt those. Bowman Olds, PWC LEPC, motioned for the meeting minutes to be approved. Jason Thompson, Fairfax County PD seconded the motion. Motion carried and was approved.

REGULAR COMMITTEE REPORTS

Public Communications:

Gregory Zebrowski, Fairfax County VDEMS reported that their communication efforts are good and they're still using multiple means of messaging through Fairfax alerts, social media, and their community. Engagement keeps working on new products and technologies every day to figure out how they can continue to send out the message.

Business Outreach:

Greg Zebrowski reported that they continue working with their Department of Economic Initiatives and building relationships; pushing preparedness and messaging out through the many vast number of Chambers of Commerce that are within Fairfax County.

HMERP Exercise Subcommittee:

Trice Burgess, Fairfax County FMO reported that Chief Kristi Bartlett, Fairfax County FRD was running late this morning and nothing new on the exercise other than it's normally held in the fall or early winter each year.

CCC Liaison:

Bart Routh, SICPA, attended the CCC Liaison meeting as the Fairfax LEPC liaison; they went over each of the areas and got reports from the different areas. The next meeting will be April 25th.

Ways and Means:

Trice Burgess reported that Erik Peterson from Inova was not available today and he didn't provide any updates.

Liaison with other LEPCs:

Bowman Olds, PWC reported that they had their last meeting on March 12^{th,} and they started the meeting with a special tribute and remembrance to Brian Atkins, their Prince William County HazMat coordinator for two years. Brian had an outstanding and stellar service with the city of Alexandria for almost 31 years and he left us with a lot of great memories and did a super job with us within our LEPC. We continued the meeting looking at some response highlights.

Additional Issues:

Bowman Olds reported that in most counties as they go through this process, especially from quarter to quarter where they had initially an illicit discharge of motor oil that migrated to the county, the suspect was charged and mandated the cleanup took place; that problem was solved for us.

Another issue, a home that was being cleaned out due to a resident that had passed away, they had discovered a Korean era gas grenade that was taken care of by the Virginia State Police. EOD, who assisted in the disposal there.

A third incident occurred in March of this year involving a vehicle accident with the vehicle and vehicle fluids in a creek which they were unable to recover. The product spilled from the car and was removed by the towing company.

In terms of response highlights included the propane bobtail truck that overturned and ended up with the flared product; that was quickly resolved.

Lastly, the HazMat program status was discussed covering such items as a compliance support with pepperoni and Sarah, Title 3, and OSHA HAZWOPER standards.

Bart Routh reported that he also attended the Loudon County LEPC meeting March 26^{th.} Highlights:

- Presentation on the Hidden Lane Superfund site that's in Loudon County. There's a water plume that is going towards the Potomac River; just getting started on that clean up.
- Recent Incidents: Hanger fire at the Leesburg Airport.
- Regular occurring gas lines strikes by construction.

SUBCOMMITTEES REPORTS:

HAZMAT RESPONSE TEAM (HMRT) UPDATE

RECENT INCIDENTS

Trice Burgess reported that last week they had an overturned aviation fuel tanker at Davison Airfield, Fort Belvoir, that we assisted on. They lost a couple of 1000 gallons of fuel; most of it had been cleaned up by private contractors. They pumped the tank off; it was taking care of. The event probably went for eight or ten hours or so.

HMRT TRAINING

Trice Burgess reported that his team is still doing monthly training; they're prepping for becoming a state asset, taking adding training and testing throughout the remainder of this year to get prepared for the state test.

FJLEPC COORDINATOR UPDATE

Trice Burgess reported the 2023 annual Tier 2 reporting period is now closed, the due date for that is March 1st of each year.

- 425 facilities completed their 2023 annual reports.
- One facility that initiated off the 2023 but have not submitted and signed it yet.
- 154 facilities submitted revisions because we've been asking for all the chemical safety data sheets (SDS) to be attached to your ports, and a lot of them weren't coming in. HazConnect no longer has a third-party vendor providing us with that information. So that's the reason we're asking for the SDS sheets this time around.
- Seven facilities also submitted updates for the 2023.

- LEPC does not have any funding or no way to compensate you for your time (those who volunteer), but
 maybe you can work with your supervisor or with your company; maybe they could see this as some
 type of you know volunteer mission for you to get compensated somehow, maybe get a flex time or
 something like that.
- Follow up with Chairman Michelback if interested in volunteering.

- Chief Bartlett reported an incident down at Fort Belvoir; a truck that overturned and pumped off remaining fuel from truck; they had the incident mitigated right around the crash site and did a great iob.
- Matthew Adkins reported that he is happy to be back home. He spent about 12 years as the HazMat
 coordinator Prince William County, ran off to private sector for a couple years and returned. We're
 going to do our best to make sure that Brian's memory is maintained here in the community, and the
 county, because he did a tremendous job. I'm glad to be back and I'm looking forward to participating
 in the LPC here as well.
- Christopher Haupt, DBHDS, I'm from the North Virginia Mental Health Institute. I don't have anything to report. I like to just sit in on these meetings and see what's going on and see if there's any learning opportunities, but I appreciate it.
- John Higginbotham, VDEM reported that he's getting ready to put on a HazMat Technician School next
 month that will be hosted by Prince William. We'll have attendees from Prince William, Loudon, MWAA,
 Fairfax, and one FBI agent that'll put 30 new technicians on the street and then we're prepping for one
 with Fairfax at the end of September.
- Monika Mihaley reported that she's a member of the public, a recent graduate with her MPH and she's here to learn more.
- Chairman Michelback reported nothing to report, however, he wanted to thank the leadership team
 of LEPC, Chief Barrett, and Vee for helping out while he was out. He missed the last meeting due to
 some small health issues; thanks for filling in for me last meeting.
- Bart Routh, SICPA, reported that they work closely with the BEP, making security inks for them, and that the BEP is building a new facility in Maryland.
