HAZMAT RESPONSE TEAM (HMRT) UPDATE

RECENT INCIDENTS

Battalion Chief Kristi Bartlett reported that there was a fuel spill incident at MITRE Corp that has now been cleaned up. They had a fuel leak that got into a stream. There has been an increase in lithium battery calls.

HMRT TRAINING

John Higginbotham with VDEM reported that they are currently on Day 4 out 10 for the Fairfax County Hazmat technician class. Twenty-four firefighters from Fairfax County and two from Prince Willam County are going through the program.

Trice Burgess reported that currently in our HazConnect Management Records System for our Tier 2 facilities we have:

- Sulfuric acid in lead-acid batteries used for computer battery backup power systems is EHS at the vast majority of our CHF.

 staff support functions for the foreseeable future. I want to thank Vee for all of her help this past year with
 getting the minutes and agendas out. Again, thank Vee for all of her assistance.
