### IMPORTANT!

- You are responsible for the containment, cleanup and proper disposal of the hazardous materials in your charge.

# YOU MUST REPORT ...

... all spills, discharge or release of hazardous materials. Some common products that require reporting are:

- Gasoline
- Diesel Fuel
- Oil
- Aviation Fuels
- LPG (Propane)
- Waste Chemicals & Oils
- Chlorine
- Solvents
- Acids & Corrosives
- Poisons & Pesticides
- Explosives
- Organic Peroxides

This is only a partial listing of substances that may require reporting. Reporting requirements may vary by quantity of material released. Failure to report a discharge when required can result in administrative, civil or criminal penalties. You must know the code!

## HAZARDOUS MATERIALS DISCHARGE INFORMATION & NOTIFICATION PROCEDURES

A discharge of hazardous materials has occurred. This information is provided to assist you in following the proper reporting and cleanup procedures.

You are required to report this discharge to the following local agencies:

where the discharge has occurred will take whatever actions are necessary to protect public health and safety and the environment.

The public safety agency may bill the responsible party for the expenses incurred to protect the public and the environment.

Based on the nature of the hazard presented by this discharge, public safety personnel may be obligated to standby until the hazard is controlled. In addition, public safety personnel may use materials to control a spill, protect the environment, and mitigate the hazard. These material and personnel costs may be charged to the responsible party.
