# **Roundtable / Member Updates**

Trice Burgess called for roundtable/member updates.

- Doug O'Neal with GMU advised they had visits from VA DEQ for inspections involving underground storage tanks. They are also working on their five-year renewal of their integrated contingency plan. They hope to complete the plan by August.
- Erik Peterson, Inova Fairfax Hospital, advised they had an eight-hour HAZWOPER recertification class. They will have a meeting with their hospital chemical response team in May.
- Bart Routh with SICPA Securink Corp., stated the new varnish plant is in business. They will be looking at decommissioning the old plant at some point.
- Liza Sabine, Fairfax County Health Department, stated they will be having a chemical mass casualty incident tabletop exercise sponsored by the VA Department of Health. The health department will be participating in that. It's open to public health, Emergency Management, LEPCs, healthcare coalitions and other relevant stakeholders, so I wanted to mention it in case anyone here is going or is interested in more information. The exercise is this coming Monday, April 14th, local to Fairfax. It'll be some unidentified chemical with some type of water impact. So potentially surface water, groundwater, etc. So let me know if anybody wants more information on that.
